Buy Art, Save the Internet NAME.SPACE v ICANN Showdown in Court

You've heard about "Net Neutrality" but most are unaware of the monopoly that controls the Internet's Domain Name System and the impact it has on free speech and access to the web. You need to know about this lawsuit, NAME.SPACE v. ICANN, Social Entrepreneur, Cooper Union Alum (A '82) and '88 Tompkins Square Park Riot videographer Paul Garrin's battle to preserve the people's Internet.

Oral arguments in the domain name antitrust lawsuit NAME.SPACE v ICANN (the Internet Corporation for Assigned Names and Numbers) are scheduled for March 6, 2015 in the Ninth Circuit Court of Appeals in California. This lawsuit will impact the future of the Internet – whether only large corporations dominate, or whether citizens can build own and operate Internet infrastructure as a social business.

In order to raise money for the NAME.SPACE v. ICANN legal fund, Paul Garrin is exhibiting for the first time his black and white photography works from 1980 - 1984, and conducting a silent auction to sell prints that include images of Nam June Paik and Joseph Beuys, Velvet Underground's NICO, and portraits of friends, moments, and scenes from nightlife, alternative music, and the City. The exhibit and silent auction kicks live off at the new MAX FISH at 120 Orchard Street (Delancy/Rivington) on Sunday February 8, 2015 from 7PM - 10 PM and continues through February 20, 2015.

In addition to the photographs from his archives, Paul will also be previewing (for sale) some bigger ticket items from a new digital video art edition series that celebrates his long time collaboration with the late video art pioneer Nam June Paik, in anticipation of the 10th anniversary of his passing (January 2006).

Funds raised will be used to send NAME.SPACE attorneys from Morrison & Foerster http://MoFo.com to California to present oral arguments before the Ninth Circuit.












